Please review the amended copy of the By Laws included in this addition of the Man-of-Honor newsletter. We will be discussing and voting on the By Laws as written at the March 10th meeting.

By-Laws Man-of-Honor Society

FORWARD - All members, past and present of the U.S. Military who have served honorably are welcome to join the Man-of-Honor Society. This membership holds the obligation to uphold the goals of these By-Laws and to enhance "Esprit"-de-corps of all those who are members.

Our Creed:

"You have served so that others may live. You are a true American Man-of-Honor. The people of the United States are Grateful".

• The Man-of-Honor Society was founded on May 14, 2004.

MEMBERSHIP - Membership is open to all U.S. Military Veterans, Active Duty, Reserve or National Guard who have served honorably or are still serving.

- There are no dues in this Society.
- Associate members will be allowed into the organization when they are nominated by a regular member. Nominations must be in writing, reviewed by the Elected Officers and if they meet the criteria for membership will be voted upon during a regular meeting. Again, all nominations must be in writing. Under no circumstances will a person be nominated and voted upon during a regular meeting. The number of Associate Members will not exceed 10% of the total voting membership. Associate members are not allowed a vote and must be at least 21 years of age. Associate members are allowed to wear the white MOH dress caps and shirts with the logo of any military branch of service on the caps.

OFFICERS - Elected Officers will consist of the President, Vice President, Secretary, Treasurer and Sgt-of-Arms. Normal term of office will be 24 months starting in January of the odd numbered of years. The elections will be at the November meeting. Officers may be re-elected to their previous office or to any of the other offices.

• The President will appoint a Public Relations Director whose duties will be at the discretion of the elected Officers.

MEETINGS - The regular meeting location will be in the Newsletter and/or via Web Site.

- Bi-monthly meetings will be held on the 2nd Saturday of the scheduled month starting in January and called to order at 2 p.m.
- Special meetings may be called at the discretions of the elected officers.
- Approval of the votes will be subject to the majority rules of voting members of the Man-of-Honor Society.

MISSION STATEMENT - The mission of the Man-of-Honor Society is to unite all U.S. Military Veterans, Active duty personnel and members of the Reserve and National Guard, and to show Honor and Respect to one another for what they have done and in some cases are still doing to defend this great nation of ours.

MOTTO - Integrity, Honor and Concern.

GOALS - To assist our fellow military members of Marathon County, past and present, who are enduring hardships due to circumstances unforeseen. Such as, but not limited to, military deployment, transportation to VA Facilities, medical bills or others as deemed appropriate. These goals can be met through fund raisers, raffles or sale of goods and/or merchandise. The events must have at least one voting member on the committee, and will serve as Chairman. This is a

Non-Profit organization. Assistance to someone outside Marathon County will be voted on by the members and will be on a one-time basis only.

- Funerals A donation of \$200.00 for immediate family members.
- Provide transportation, when needed, for members to doctors, hospitals and funerals.
- Provide transportation for fundraisers, meetings, and special events, however, the Man-of-Honor Society will be held harmless of any mishaps that occur when in the Man-of-Honor Van. Cost of driver and fuel is the responsibility of the person and/or persons requesting the use of the Man-of-Honor Van.

ASSISTANCE REQUESTS - Members may submit requests for funds in writing or e-mail to the Board of Officers if they know of warranted situations. Requests should state exactly what the funds will be used for, the amount needed to solve the problem and any other information to help the membership vote on it. Emergency requests up to \$500.00 may be approved by the Board of Officers. An approved request by the Officers will be announced at the next meeting. A "Call for Action" request may be sent for emergencies to the members by the President or Vice President via e-mail and will be detailed by the cost, what it is for, explain the emergency, and any other available information. Remember: Although we want to help as many people as we can, we also have a responsibility to only give the individual an amount not to exceed the request to solve the problem. A vote to give a higher amount will be considered.

• No funds will be disbursed without the final approval of the President and at least one other Officer.

AUDIT - The board members, at their discretion, will appoint a member of the organization to periodically, but at least once per year, audit the financial statement. The Treasurer will give the appointed auditor all documents required to complete the audit. A CPA or accountant will be hired by the MOH.

COMMUNICATIONS - A newsletter will be published bi-monthly and sent to all members by e-mail and posted on the MOH web site. The postal address for the Society is P. O. Box 5112, Wausau, WI 54402. The telephone number is 715-212-1348.

UNIFORMS - The normal uniform for any special function will be white cap, white shirt and black pants. The President will advise for any function.

AWARDS -

President's Award

An annual Presidents Award will be given to the MOH Regular or Associate Member who has outstandingly contributed to the mission of the Society during the year. The deserving person must be nominated by a Regular Member to the President in writing stating why this person should receive the award. The award will be presented at the Annual Christmas Party.

Special Award

An annual Special Award will be awarded to the Organization or Person who has supported the MOH in an exceptional manner.

SPOTLIGHT ON ONE OF OUR OWN - The Spotlight may be published in the bi-monthly newsletter. All members are eligible to be Spotlighted, but the member submitting the person must do so in writing not later then the 15th day of the preceding month of the next newsletter. If more than one nomination is submitted, the President will select which one will be published.
